To assist in providing the most efficient customer service and to expedite your visa processing, the Consular Section of the U.S. Embassy in Ankara U.S. Embassy in Ankara provides the following additional information. This information sheet contains detailed instructions regarding post specifics.

## LIST OF THE DOCUMENTS REQUIRED AT THE INTERVIEW

1. PHOTOS: Two current photos of each applicant. Please write your name at back.

2. PASSPORT: Original passport of each applicant.

## 3. ORIGINAL AND TRANSLATION OF CIVIL DOCUMENTS:

\* Marriage Certificate: One copy for each applicant;

\* Birth certificate: "Shenasname" for Iranian applicants;
"Nufus Kayit Ornegi" for Turkish applicants;
"Hawiat Al Ahwal Al Madniya" for Iraqi applicants.

\* Military card: For Iranian applicants only;

\* National ID card: "Cart e Meli" for Iranian applicants; "Shahadat Al Jinsiya Al Iraqiya" for Iraqi applicants.

**4. MEDICAL REPORT**: Before their final immigrant visa interview, all applicants are required to undergo a medical examination performed by one of several medical doctors authorized by this Embassy to administer the examination. Beneficiaries are responsible for making their own arrangements for the medical examination with any of the physicians listed on the attached medical information sheet. The beneficiary is also responsible for the cost of the examination. A medical examination is also required for each accompanying child.

**Do not send the results of your medical examination to this office before your interview.** You will be required to submit your medical report to this office at the time of your interview. Do not bring x-ray film to the Embassy.

**5. POLICE CERTIFICATE:** Police certificate is not required from Iran. **Police certificate is required from Turkey.** Turkish nationals should contact the closest "Cumhuriyet Savcılığı" (Public Prosecutors Office) to obtain Turkish police certificates. Police Certificates from Turkey are known as "Adli Sicil Kaydı". IMPORTANT: <u>When requesting the police certificate (adli</u> <u>sicil kaydi)</u>, <u>applicants must specifically request that both the **current and archived** records be <u>shown on the document.</u></u>

6. PHOTOS: Regardless of age, all U.S. Immigrant Visa applicants must present two un-retouched color photographs, approximately  $2 \times 2$  inches ( $5 \times 5$  cm) in size, taken on a white background. We cannot use photographs which do not meet the requirements:

Addresses and phone numbers of photo studios familiar with immigrant photo requirements are included for your convenience. Photos that meet the requirements can be taken at any photo studio.

## **MOST IMPORTANT**

No assurance can be given in advance that a visa will be issued. A consular officer can make a decision only after

the formal application and all documents are reviewed, and that officer has personally interviewed the applicants.

**IMPORTANT:** Beneficiaries should not make any travel arrangements for departure, dispose of personal property or make other life changes until the visa has been issued. An immigrant visa is valid for a maximum of six months from the date of issuance. Applicants must travel and apply for admission to the United States before their immigrant visas expire. The validity of your immigrant visa will be limited with the validity of your medical report.

This office will make every effort to expedite the process. However should complications arise, applicants may be required to return to this office or furnish additional information.

Any child age 16 or older who is included on his or her parents' passport but whose photograph is not included in such passport, must obtain a separate passport.
